## 강의내용:

본 세미나는 21세기 탈근대 세계정치의 본질을 네트워크 세계정치론의 시각에서 탐구한다. 제1부에서는 네트워크 세계정치에 대한 학계의 논의를 현실주의, 자유주의, 마르크스주의, 구성주의, 복잡계/네트워크이론 등 국제정치이론의 관점에서 검토한다. 제2부에서는 기술, 정보, 문화 등의 영역에서 관찰되는 네트워크 세계정치의 경험적 사례를 분석한다. 본 세미나가 주목하는 것은 기존의 노드 중심의 국제정치(國際政治, inter-national politics)를 넘어서 네트워크 행위자들 간에 형성되는 '망제정치(網際政治, inter-network politics)'이다.
